**General Notes/Comments:**

On November 15, 2024, Horsley Witten Group, Inc. (HW) staff performed a site visit along the Eversource Transmission Line corridor in Sudbury, MA. During the site visit HW walked all segments with erosion controls installed (7-14) and confirmed erosion control practices at the gravel construction entrances are still in working condition.

- Silt fence and filter tube are functioning properly along segments 8-10.
- Tree stumps removed along segment 7 (Photo 1).
- Several rips and broken stakes in the silt fence along segment 7 (Photo 2).
- Several broken stakes in the silt fence along segment 11 (Photo 3).
- Several broken stakes and rips in the silt fence along segment 12 (Photo 4).
- Several rips in the silt fence along segment 13 (Photo 5).
- Rip in the silt fence along segment 14 (Photo 6).

**Action Items:**

1. Repair silt fence as noted above.
