# Community Preservation Committee September 19, 2002 Town Hall

Mark Kablack opened the meeting at 7:35 pm. The committee reviewed the minutes of Aug. 29, 2002 and approved them with minor corrections. One substantive comment was made regarding recreation projects in Bedford. Although reserving funds for recreation is not a statutory requirement of the Act, Bedford did have a skateboard project that they reserved \$40,000 for.

CPC again discussed the role of the members as conduits of various boards and committees. Statute apparently contemplated representation by specific boards on the CPC. Obviously representatives will advocate for their own interests. Committee will have to balance advocacy with the multiple facets of the Act.
