**Sudbury Historical Commission**  
**CPC Application for Indigenous Cultural Landscape Study FY 2024**

**Project Need**

The Sudbury Historical Commission is submitting this application to the Community Preservation Committee (CPC) for Community Preservation Act (CPA) funding to complete an Indigenous Cultural Landscape Study. This study fulfills a matrix action recommendation of the Town-wide 2022 Historic Preservation Plan (HPP), which was a project prescribed by Sudbury’s 2021 Master Plan. Protection of all of Sudbury’s historic and cultural resources, including archaeological, is an important tenet of both plans. Such resources have unique characteristics and requirements for their identification and management, including the need for intact patterning within undisturbed terrain and also an understanding of any continued cultural ties. Protection and preservation of these resources often falls outside of state and federal regulatory tools but are especially vulnerable to local land-use decisions resulting in ground-disturbance<sup>1</sup>.

Under MGL Chapter 40 Section 8D, the Historical Commission is charged to “protect, preserve and develop the historical and archaeological resources of the town.” Above-ground historical resources have for the most part been well identified and surveyed at the initiation of the Historical Commission. However, archaeological below-ground resources and Indigenous cultural landscapes have not and there is an urgent need to fill in the gap in knowledge about these historical resources.

This proposed Indigenous Cultural Landscape Study will provide Sudbury with the identification of and planning tools necessary to protect and manage these resources. This study will supplement the Master Plan’s Baseline Report<sup>2</sup>, which concentrated on the post-contact historic resources. Pertinent to the Master Plan’s Action Plan Matrix<sup>3</sup>, the current proposed study will address the following actions, two of which are short-term (within 5-years) actions and one of which is a Critical Path Action:

- A.2 Appropriate funding for and develop a town-wide Historic Preservation Plan with the involvement of stakeholders. Items addressed in the plan could include, but will not be limited to:
  - a) Ongoing survey and study of non-documented and under-documented historic and archaeological resources and/or those not fully understood. (Short-Term, within 5 Years; Critical Path Action)

- A.4 Develop a sophisticated and accessible platform for the Town’s historic and archaeological resources inventory that can be used to support local permit review and educate residents and property owners.
  - a) Create a complete digital inventory of historic structures, sites, landscapes, roads, and significant features (e.g., stone walls) throughout Sudbury.
  - b) Identify and inventory historic structures, buildings, sites, and landmarks that have not been inventoried or those inventories which are out of date.
  - d) Link with GIS data to better inform and shape the effectiveness of preservation and planning policies. (Long-Term, more than 10 years. Note: access to be restricted with the sensitivity map to be the primary tool for planning and permitting decisions.)
  
- B.1 Develop a Historic Preservation Primer for all local boards, commissions, and committees that clearly describes the variety of historic preservation regulatory tools in the community, powers, and limitations, and how they function together. (Short-Term, within 5 Years. Note: study will be used to raise awareness of fragile, non-renewable archaeological resources in general without divulging locations.)

### **Project Description**

As recommended within the HPP, the proposed study will include a town-wide archaeological sensitivity assessment (i.e., reconnaissance survey or overview) and, if and when found, identify Indigenous site locations called Traditional Cultural Properties (i.e. locations associated with ceremonial, sacred, or other occupational connections). As explained within the HPP, the recommendation and goals are as follows:

***RECOMMENDATION:***

***Prepare a study of the Indigenous Cultural Landscape in Sudbury relating the Town’s various natural landscape areas with Native American occupation, use, and significance.***

- *Assess the characteristics of Sudbury’s glaciated landscape during the precontact period;*
- *Summarize Native American history with a special focus on the several hundreds of years prior to contact;*
- *Review known archaeological sites and resources that have been identified in Sudbury [i.e. existing conditions or baseline data];*
- *Review how Native American peoples used and impacted different character areas within the landscape;*
- *Assess the types of archaeological resources that might be found there today; and*
- *Prepare an archaeological sensitivity map for the Town.<sup>4</sup>*

At this time, to accomplish the above, it is envisioned this study will be comprised of the following four phases:

- Phase I. Preliminary baseline study, environmental conditions, preliminary sensitivity assessment, and preliminary sensitivity map.
- Phase II. Specialized analyses if appropriate and can be accomplished within budget. This may entail coordinating with other interested parties and funding.
- Phase III. Documentation of new sites through public events, targeted field site visits, and discussions with interested groups.
- Phase IV. Preparation of predictive model, final sensitivity map, and report. At this time, consultant may outline specific Research Questions for future work, such as:
  - Further delineation of Sudbury's paleo-landscapes.
  - Identification of raw material locations.
  - Indigenous culturally significant floral study.

**Community Support**

Support for this application will be sought from other Town entities. Those for which the sensitivity map and management strategies will be most beneficial will be the Select Board, Planning and Community Development Department, Planning Board, and the Historic Districts Commission.

**Justification for Cost: Examples of CPC Funding for Similar Projects in Other Communities**

Comparable past CPC funding bestowed to other communities is summarized in **Table 3**. Generally, the town-wide surveys range between \$25,000 and \$35,000. Wareham, however, is much less--\$8,000--even though this town encompasses the largest geographical area. While a cursory overview could be accomplished for this amount providing just the existing conditions (i.e., known sites), the additional goals set out by Sudbury’s HPP could not be. For this reason, most comparable as far as geographic size are those of Chatham and Yarmouth. Comparable for the desired end goals is the Groton plan<sup>6</sup>, which includes management and interpretive plans.

I am writing to recommend the CPC fund the Indigenous Cultural Landscape Study as recommended in the 2022 Historical Preservation Plan (HPP)

The protection of all of Sudbury's historic, cultural, and archaeological resources was also an important tenet of the Sudbury 2021 Master Plan. This is especially needed to guide the course of future development.

It will also boost civic engagement. From HPP: "A significant number of residents in Sudbury expressed interest in Native American history and archaeological resources during preparation of the HPP."

In addition, the town has undertaken a reckoning of with the colonization of Sudbury. This past summer, two DEI Commissioners met with two representatives of the Wayside Inn.
