

Information and Application for Affordable Homeownership 12, 18, 24 Graystone Lane, Natick MA 01760 \$312,700

This packet contains specific information for the purchase of three deed restricted units at Graystone Lane in Natick, MA, including the eligibility requirements, the selection process, and a lottery application form.

This application is a first step in the lottery process and does not assure you a home. Applicants must secure approval for a mortgage loan, submit evidence of such approval together with the application, and be ready to buy.

Project description

Graystone Lane is a, picturesque residential development of 16 high-end single detached homes, and 17 condominiums, in 2 and 3 unit townhouses, Located in South Natick. The three affordable units are condominiums.

The affordable condominiums are located at 12, 18 and 24 Graystone Lane. They are all 3 bedroom, 2 ½ bath units, on two floors with 1363 square feet of living area.

The units have an open floor plan downstairs, with living room, dining room, kitchen, mud room area, and a half bath. The bedrooms are upstairs, along with two baths and a laundry room. The first floor has a deck leading out to a fully fenced yard. Each unit will have a one-car garage.

The units feature wood look plank flooring throughout the entire first floor. The kitchen features Amana appliances, with White Cabinetry and Gray countertops, as well as an island with seating areas. The second floor features two full bathrooms, one with a tub/ shower combo, and one with a shower stall. The bedrooms feature carpet. There is a pulldown attic with space for storage, and an unfinished walkout basement.

There is gas heat and central air conditioning.

The purchase price is **\$312,700**. Owners are also required to pay property taxes, and the 2022 Natick tax rate is **\$13.61** per **\$1,000** of valuation or an estimated monthly amount of **\$389**. The condominium fee is currently **\$138** per month, and the Condominium Association has rules and regulations for all owners that describe the operation of the condominium.

Lottery Description:

- 1. The application for this housing opportunity will be generally available, including on-line, in hardcopy at the Regional Housing Services Office and Natick town office, and sent to anyone interested in the lottery. Notice of the lottery will be advertised, and communicated widely through local, regional and state channels.
- 2. Applications are to be submitted with all required information by the deadline. Applications can be mailed or dropped off at the address above. Applications that are dropped off should be placed in the big black metal mailbox outside the RHSO office building. Applications may also be emailed, but accompanying documentation must be compiled such that the total submission email/s has no more than 5 attachments, with the applicant consolidating the information. Applicants are encouraged to complete the checklist as an aide to the process.
- 3. The applicant's household size will be determined from the application, and the required number of bedrooms as indicated on the application. Priority shall be given to households requiring at least the number of bedrooms in each unit. Smaller households are encouraged to apply.
- 4. The maximum gross household income will be verified and compared to the HUD 2022 published income limits. 1 person- \$78,300, 2 person- \$89,500, 3 person- \$100,700, 4 person- \$111,850, 5-person- \$120,800, 6-person- \$129,750
- 5. The household assets will be verified and compared to the \$75,000 maximum asset limit. Assets include but are not limited to all cash, cash in savings accounts, checking accounts, certificates of deposit, bonds, stocks, cash value of retirement accounts, value of real estate holdings, any gift amount and other capital investments. Equity from the sale of any home will be included with other household assets that cannot exceed a total of \$75,000.
- Eligible applicants must be a First-time Homebuyer. This is further defined as a household that has not owned a home 6. within three years, including in trust, preceding the application, with the exception of displaced homemaker, single parents and senior households (at least one household member is 55 or over). Any previously or currently owned home must be sold prior to purchase of the affordable unit.

A displaced homemaker is an individual who is an adult, who has owned a home only with a spouse, who is legally separated from a spouse, and who does not currently own the home previously owned with a spouse.

Single parents are individuals who owned a home with his or her partner or resided in a home owned by the partner and is a single parent (is unmarried or legally separated from a spouse and either has 1 or more children of whom the individual has custody or joint custody, or is pregnant);

Additional exceptions are made for households that owned a principal residence not permanently affixed to a permanent foundation, and households that owned a property that was not in compliance with State, local or model building codes.

Eligible applicants cannot own residential property, whether for primary, secondary or investment purposes.

- 7. Persons must submit all the necessary information by the application deadline. Late applications (applications mailed and/or received after the above date) and applications that are incomplete will not be accepted. No faxed or emailed applications will be accepted.
- 8. All applicants will be screened for eligibility. Applicants who have been deemed ineligible will be notified in writing of the decision and given time to contact the lottery agent in writing to disagree with the determination.
- 9. Once the Lottery Agent has verified the information contained in the application and confirmed eligibility, a lottery number or numbers and lottery form will be issued, and the applicant will move forward to the lottery.
- 10. Applicants that qualify for the local preference will be placed in the local pools. One of the units is available for local residents. Applicants will be entered into all the pools for which they qualify; so a local resident will be included in both general and local pools. The Town is committed to providing equal access to all applicants. In the event that the pool of applicants with a local preference does not include at least 33.4% of households who have one or more member who is a minority as defined in the application, then other eligible minority applicants will be included in the lottery for the local preference units through a minority pre-lottery.

Local resident includes:

- Current Natick residents, or
- Families with children in Natick schools, or
- Natick municipal employees; or
- People employed by businesses located in Natick, including with a bona fide offer of employment.
- 11. A final lottery eligibility letter will be mailed to each applicant indicating their final eligibility determination and the lottery specifics (date/time).
- 12. The lottery numbers will be pulled randomly in a public setting. Lottery numbers will be assigned a number in the sequence in which they are drawn and recorded in the order of selection on the Lottery Drawing Lists. The list of numbers drawn will be posted and letters will be mailed within three business days to the winners.
- 13. Once the tickets have been randomly drawn and listed in the drawn order, the units are then ranked based on bedroom size. The top ranked household needing at least the number of bedrooms in the unit will be offered the opportunity to purchase the unit. The household size preference shall be given to households based on the following criteria.
 - There is at least one occupant per bedroom.
 - A husband and wife, or those in a similar living arrangement, shall be required to share a bedroom.
 - Other household members may share but shall not be required to share a bedroom.
- 14. The lottery agent shall maintain all Lottery Drawing Lists. In the event that any of the applicants withdraw for any reason, or do not comply with the guidelines, the next qualified applicants in the lottery pool ranked by bedroom size need, will be offered the unit.
- 15. As the Monitoring Agent, DHCD will then review the buyer's income, assets and other criteria before the buyer can proceed to purchase the unit. Approved applicants will be given 5 days to agree to purchase the unit before the next person can be offered the opportunity.
- 16. Upon the satisfaction of the qualification requirements of both the Lottery and Monitoring Agent, the qualified buyer is then able to move forward and execute the Purchase and Sale with the seller. The qualified buyer will be given reasonable time to sign a Purchase and Sale, 3 weeks.
- 17. All potential buyers are encouraged to attend a First Time Homebuyer Class prior to closing. Organizations offering these classes can be found at www.chapa.org.
- 18. The State programs and bank products have specific closing and financing requirements. Current mortgage requirements include:
 - The loan must have a fair and fixed interest rate through the full term of the mortgage.
 - FHA Mortgages and family mortgages are not approved for this project.
 - The loan can have no more than 2 points.
 - The buyer must provide a down payment of at least 3%; half must come from the buyer's own funds.
 - Non-household members shall not be permitted as co-signers of the mortgage.
 - The buyer may not pay more than 38% of their monthly income for monthly housing costs.
 - Loans from non-institutional lenders will not be accepted.
- 19. The Fair Housing Act prohibits discrimination in housing because of Race or color, National origin, Religion, Sex, Familial status. An applicant who believes that they have been discriminated against in the buyer selection and sales process may contact: the Massachusetts Commission Against Discrimination; and/or the United States Department of Housing and Urban Development.
- 20. Disabled persons are entitled to request reasonable accommodation of rules, policies, or services, or reasonable modification of housing.
- 21. Resale process: The Monitoring Agents (DHCD and Town of Natick) have up to 90 days after you give notice of your intention to sell the home to close on a sale to an Eligible Purchaser, or to close on a sale to a Monitoring Agent, or to a buyer that one of them may designate. This time period can be extended, as provided in the LIP Deed Rider, to arrange for details of closing, to locate a subsequent purchaser if the first selected purchaser is unable to obtain financing, or for lack of cooperation on

your part. If you attempt to sell or transfer the home without complying with the LIP Deed Rider requirements, the Monitoring Agents may, among their other rights, void any contract for such sale or the sale itself.

The unit cannot be refinanced without prior approval of DHCD, as Monitoring Agent, no capital improvements can be made without the Monitoring Agent pre-approval; the unit must be owner's primary residence; the resale price is calculated according to the deed rider; and an increase in equity is very minimal to ensure affordability over time; the deed rider remains in effect in perpetuity. All prospective buyers are advised to review the deed rider with their own attorney to fully understand its provisions.
