Call to Order

Nancy Marshall called the Public Meeting to order at 7:40.

Green Communities Update

Nancy Marshall invited Rami Alwan to update the Committee on Sudbury's Fuel Efficient Vehicle policy. This was originally put into place two years ago and this is a renewal. The school vehicles are exempt from the policy because of the gross vehicle weight classification, but by signing on to the policy we become eligible for grants. We received over \$10,000 under the program. Radha Gargeya noted that it is a great program.

On a motion by Patty Mostue, seconded by Kevin Matthews, the School Committee voted unanimously to adopt the policy and to authorize Nancy Marshall as Chair and Scott Carpenter as Administrator to sign the policy and to add it to the School Committee Policy Manual.

Student Representative Report

Emily Casey was absent but sent her report through Nancy Marshall. She thanked Leslie Belcher and Paula Myers for working on extending the library hours. This is great for kids who have sports after school. Students hope that the 6 week trial period will work out.

The mobile app is completed and they are publicizing it. The students are also planning a second anti-stress week.

Teachers' Association Report

Lisa Weiss briefly reported that second semester was up and running. The Math Department is very excited about hosting the Math Olympiad.

METCO Representative Report

Juanita and Jesse spoke about the concerns last year among METCO parents about communication and that there is significant improvement this year under Janine Dailey. They are working on a parent meeting; they had the first scholarship meeting to mobilize people to support a scholarship for a METCO student; and they are planning a fundraiser in March.

Chairman's Report

Nancy reminded the Committee that the Suburban Coalition was holding a meeting on the same night, February 15th at 7:00 pm, on the same topic – the Mass. Budget & Policy Center report on school funding "Cutting Class: Underfunding the Foundation Budget's Core Education Program" - as the presentation in Worcester through MASS and MASBO. The Suburban Coalition meeting is at the Newton Marriott and Noah Berger of Mass. Budget & Policy will be the presenter.

L-S is presenting its play tonight, tomorrow night and Saturday. It is a comedy called "Laugh Out Loud".

David Grace's lecture and discussion, entitled "US Foreign Policy with Egypt: A Year After Arab Spring," will be on Thursday, February 9 at 7:00 PM, LS Lecture Hall A217.

The School Committee was invited by the Lincoln Finance Committee to meet with

senior citizens at the Senior Center on February 10th at 1:00 pm.

Nancy will be inviting the legislators to attend the Joint Finance Committee meeting in Lincoln on February 7th at 7:30 pm.

Nancy also noted that there will be a meeting for "Youth and Philanthropy".

Liaison Reports

There were no Liaison reports.

Superintendent/Principal's Report

Scott Carpenter spoke about how the early release day today for the full faculty was used to follow up on a panel discussion with students of color. Scott then used some of the time to walk through the budget presentation focusing on issues such as the Special Education needs, rather than on the numbers.

Information & Discussion

Update on Minuteman Nashoba Health Group and Insurance ChangesJudy noted that almost all of the 17 members of the MNHG had successfully negotiated the implementation of the new plan designs and mitigation plans.
Like L-S, most had accomplished it outside of Section 21. In addition, the trend downward in claim costs has continued and for the first time the group has reserves slightly above the full amount of the target for the group. This will help the group to keep plans and rates stable.

Surplus Property Procedures

Judy Belliveau had provided a draft of Surplus Property Procedures for the District to adopt in order to be in compliance with the State in having a written protocol. Kevin Matthews asked for clarification on the \$5,000 value as to whether it was per single item or for a group of items being disposed of. Judy offered to bring clarification to the next meeting.

FY'12 Update re: Miscellaneous Revenue

Judy reported to the Committee that she expected a higher amount of miscellaneous revenue to be available when FY'12 closed out. This would roll into the Excess & Deficiency fund for reapportionment in FY'14. The revenue is a refund of postage money that had built up on account at the Post Office over a few years and we received it when we changed out our postage meter. Judy wanted to bring it to the Committee's attention because the School Committee could consider using all or a portion of the funds to help close the FY'13 gap between the District's level staffing budget and the Sudbury No Override budget.

Nancy Marshall also raised the issue of whether we should reapportion funds in the future or begin to address the District's needs for capital, building its reserves, and

funding OPEB. Judy commented that, if the School Committee adopts a procedure for applying budgeted but unspent retiree health insurance funds to the OPEB liability, the amount of reapportionment will automatically go down since the majority of operating budget funds that are unspent at the end of each year and roll into reapportionment is health insurance. Judy agreed to develop a proposal for a policy for unspent retiree insurance and find out how Sudbury did it.

FY'13 Budget Information and Discussion

Judy provided a final update on the Reapportionment amount now that Toni Benhaim, the District's Treasurer, has closed out FY'11 with the auditor. The amount went up by approximately \$15,000 based on unanticipated Regional Transportation reimbursement.

Capital Plan – Maintenance Vehicle

This discussion had been deferred from the previous meeting. Judy reviewed the memo she had provided to the Committee in response to questions that had come up. Judy was not asking for any action to be taken at this meeting but wanted the Committee to understand that it is a high priority to replace the truck. There can be a lead time of approximately six weeks so Kevin would want to order the truck in the summer to be certain he has it for the fall/winter season.

The Committee agreed with Judy and Scott as to the need. The request for a vote will be brought back to the School Committee before the end of the fiscal year.

Action Items

Vote on Surplus Property Procedures

The vote was put on hold until the next meeting.

Vote on Maintenance Vehicle

This was put on hold and will be brought back before the end of the fiscal year.

Other Business

Judy will develop a "Rollup Budget" for the Committee to vote at the next meeting as its highest budget to be submitted.

Nancy Marshall reminded the Committee about the Joint Finance Committee meeting. The agenda will focus on Special Education Out of District Placements, Capital Planning, and the FY'13 Budget.
