# **Discussion of Select Board Policy Drafts:**

### **Code of Conduct Policy:**

Town Manager Sheehan reported that he cleaned up the language of the draft Code of Conduct policy based upon comments from the last meeting. He stated that he also made some format changes. The Subcommittee discussed the policy.

### Fraud, Procurement and Purchase Contracts Policies:

Town Manager Sheehan stated that there are no anti-fraud policies currently. He stated it would be appropriate to have it in the financial policies. He indicated we should have fraud and procurement policies in the financial policies.

The Subcommittee discussed putting the fraud and procurement policies on an upcoming agenda. Town Manager Sheehan stated that it would be good to have a fraud policy in place.

As it pertains to the purchase contracts policy, Town Manager stated that former Town Manager Murphy-Rodrigues proposed increasing the

threshold amount to \$200,000. Town Manager Sheehan stated it would streamline things if the threshold were increased.

Member Kouchakdjian will draft fraud, procurement and purchase contracts policies and provide them to Member Roberts and Town Manager Sheehan for the next meeting.

# Licensing of Outdoor Amusements Policy:
