## **SELECT BOARD FEE SCHEDULE**

The Select Board is responsible for establishing the fees associated with the issuance of certain permits, licenses, and certificates. In setting these fees, the Board's objective is to recover a reasonable approximation of the Town's costs incurred in processing the requested item. Staff are required to review these fees annually and submit recommendations to the Board by December 31 of each year if they believe any adjustments—either increases or decreases—are warranted.

## **TRANSFER STATION - FEE SCHEDULE**

**Pay-As-You-Throw (PAYT)** is the two-part system of trash disposal at the Transfer Station.

1. Residents purchase a yearly Transfer Station Sticker for their car to be admitted to the Transfer Station.
2. Residents purchase designated yellow Transfer Station bags in order to use the waste collection point at the station.

Transfer Station bags are sold in packages of five (5) and come in two sizes, 30 gallon and 15 gallon. (A normal kitchen trash bag is thirteen gallons). These bags are sold in packs of 5 at local retailers and are not available at the Transfer Station.

***Per the 2006 Transfer Station Rules & Regs:***

*A waiver will be granted upon request and the completion of a form for such purpose, of 50 percent of the Transfer Station fee for those individuals 65 years of age or older who demonstrate hardship, for those persons living in subsidized housing, and for those other persons with demonstrated hardship situations.*

### **AMBULANCE - FEE SCHEDULE**

The Town establishes ambulance service rates to ensure the recovery of costs associated with providing emergency medical transportation. These rates are set to reflect a reasonable approximation of the expenses incurred, including personnel, equipment, maintenance, and administrative overhead.

Ambulance fees typically include a base rate—which varies depending on the level of service provided (Basic Life Support, Advanced Life Support I, or Advanced Life Support II)—as well as mileage charges calculated per mile of patient transport.

The Select Board reviews ambulance rates annually, with input from Fire Department and Finance staff, to determine if adjustments are needed based on service costs, billing trends, and Medicare/Medicaid reimbursement changes.

### **CEMETERY - FEE SCHEDULE**

Cemetery fees are established to cover the costs associated with the operation, maintenance, and perpetual care of municipal cemeteries. These fees apply to the purchase of burial lots, grave openings and closings, cremation burials, monument installations, and related services. The fees help ensure the long-term upkeep and respectful management of cemetery grounds in accordance with Town policies and regulations.

### **DPW STREET OPENING - FEE SCHEDULE**

The Department of Public Works (DPW) charges Street Opening Fees to recover the costs associated with the inspection, permitting, and repair of public roadways that are disturbed due to utility work, private construction, or other activities. These fees are assessed to ensure that all excavation and restoration work within the public way is performed to Town standards and does not compromise the safety or longevity of the roadway infrastructure.
