## Member reports

Radha gave an update of his attending a with the Sudbury Select Board. The Select Board approved ARPA funding of \$25,000 for the Sudbury 250 Committee to use toward events, merchandise, publicity etc. Radha mentioned again that he spoke with Carmine Gentile who filed an amendment to add \$50K funding for Sudbury 250 committee into the FY2025 Massachusetts budget, but did not have an update on the timing of distribution of those finds. As of now the funds are pending.

It was mentioned that the \$25k funding would have to be under contract by December 31, 2024.

There was discussion on applying for CPC funding. The Committee will need to further look into if Sudbury 250 would qualify for CPC funds.

#### Discussion of events

The Committee reviewed the results of the Flash Survey and the comments submitted with the survey questions. The consensus was that the survey results would guide, but not bind, the Committee in planning Sudbury 250 events.

It was agreed that events should encompass a variety of the types, locations, days of the week, times during the day, for different ages. Events should also include a variety of demographics that have been traditionally underrepresented.

The Committee also discussed an email suggesting that the Committee and events should look at celebrating the last 250 years of America, what has it achieved, invented, produced etc and not solely focusing on 1775-1776. What is America at 250?

There was also discussion about how to engage Sudbury students.

It was decided that the Committee will begin to set a schedule of Sudbury 250 events at the next meeting. In preparation the Committee Chair will send a list of proposed events. Each Committee Member will return a list of their top 5 event ideas to the Chair be they on the list from the Chair or not.
